Camp Northfield is operated according to Scriptural standards. Therefore, unbecoming language, alcohol, cigarettes, drugs, and firearms are strictly forbidden.

- No one is to leave the Camp property without the permission of the Camp Director.
- Uncooperative or disruptive campers will be sent home. No refund will be given.
- Food and drink are not allowed in the cabins.

Camp Standard Operating Procedures:

Communications: Write to campers at the camp address with the camper's name clearly printed in the lower, left-hand corner of the envelope. *Hint:* Write letters between the Wednesday prior to and the Wednesday during their camp week to insure that they receive it while they are here. Telephone calls, faxes, and visits are strongly discouraged because they tie up the phone lines and office personnel in locating campers and interrupt counselors and cabin activities. Furthermore, you may very well spark homesickness in an otherwise happy camper resulting in an unscheduled trip to Northfield for yourself.
